# **CALL TO ORDER**

The meeting was called to order by Mr. Hubbard at 10:45 a.m.

### **MINUTES**

  - o Motion was made by Mr. Willis to accept the lowest/most qualified bidder(s) **or** bidder(s) approved by Consultant Whitaker Wright, second from Mr. Evans.
  - o In addition, should there be multiple bids submitted in the same amount, motion was made by Mr. Willis to prioritize the local bidder, second from Mr. Evans.
    - Should both bidders be local, the board will be forced to revisit the bids altogether in order to determine how to proceed.

### **OLD BUSINESS**

• **Grant Program** – Mr. Radabaugh believes there may be an extension in time allotted to complete the demolition work under the grant guidelines, though it does not look like there will be an allowance to add any additional properties. No further updates at this time.

## **NEW BUSINESS**

- Wellston Representative Charlie Hudson is still considered the Wellston Rep on the Board, as the seat is not required to be filled by the sitting mayor. Because of this, Mr. Hudson will need to submit a letter of resignation. At that time, the board will have to approve the appointment of Tony Brenner to fill the seat. No action taken at this time.
- **Financial Statements** State Auditor of Ohio requires Board approval in order to complete the annual financial statements for the Land Bank. This was approved on a motion from Mr. Willis and a second from Mr. Brenner.

- **1208 S Pennsylvania Avenue, Wellston** Demolition is complete and property ready to be transferred to the City of Wellston. Motion to transfer made by Mr. Willis, second from Mr. Evans.
- 1016 S New York Ave, Wellston Property still needs transferred to City of Wellston.
- **2169 Jackson Hill Road, Wellston** Neighbor requested Land Bank list the property for sale. Minimum bid was set at \$1,250 on a motion from Mr. Willis, second from Mr. Brenner.
- **Running G Farms** Company applied to become a Land Bank pre-qualified contractor. Motion to approve made by Mr. Brenner, second from Mr. Willis.
- **Sewer Line Easement** Devin & Hayley Molihan requesting easement through LB property for their sewer line. Board has no issues, provided the Molihans cover the cost of having the easement documents professionally written & the easement runs along the border of the property. Motion to approve on those conditions made by Mr. Willis, second from Mr. Brenner.
